## **Share Purchase Plan Offer extended to Monday, 13 December 2021**

Leading Smart Cities and AI software solutions provider SenSen Networks Limited (ASX:SNS, “**SenSen**” or “the **Company**”) advises that the closing date of the offer under the Share Purchase Plan, announced on 5 November 2021 (**SPP Offer**), will be extended from Monday, 6 December 2021 to the revised closing date of Monday, 13 December 2021.
