1H FY22 Operational Highlights

- Acquired Scancam Industries, provider of AI anti-theft solutions, in July 2021
- Raised \$10m in November and December 2021 via a placement and a SPP to fund continued growth momentum






1H FY22 Financial Highlights

- **Revenues** of \$3.0m, up 19% vs prior comparative period (pcp)
 - New contract wins with a min value of \$4.782m in Q2 FY22
- Monthly recurring revenue (MRR) of \$0.45m (ARR of \$5.3m), increasing to MRR of \$0.65m-\$0.7M (ARR of \$8m+) by end of FY22
- **EBIT loss** of \$6.9m compared to \$0.5m loss in pcp; **underlying EBIT loss** of \$4.8m (excludes non-cash share-based payments expense), and in-line with previously reported net cash used in operations for 1H FY22
- Customer net retention rate (NRR) remains at 120%+
- Net cash position of \$8.1m as at 31 December 2021 (vs \$5.2m as at 30 June 2021)

Rapidly Growing Annual Recurring Revenue








Strong growth in Quarterly Cash Receipts




